# MORE WORK FOR THE CIVIL SOCIETY

In less than 2 months until the end of the year, Moldovan MPs approved a new minority government made of President Igor Dodon advisors. The prime minister Ion Chicu said his "Government is a transitional government until the next presidential elections in the autumn of 2020" when early parliamentary elections are planned to be held. The political changes restored uncertainty among civil society since the Government's action program

left out some very important issues such as improving the situation of the media and the environmental protection. Already the media and environmental organizations have urged the new Government to introduce specific objectives for these fields in its action plan. Also, civil society is not impressed with the plans for the judiciary and Prosecutor General Office. It remains to be seen how the new government will cooperate with the civil society.

# WATCHFUL AND HOPEFUL

Although Moldova has a new Government, the 20 deliverables for 2020 approved at the Eastern Partnership Summit from Brussels from 2017 remain the same. The nongovernmental organizations evaluated the results on the main priorities and discussed the gained results and remaining challenges with the central authorities. 5 thematic workshops were organized in partnership with the project Technical Assistance to Support the Development of Civil Society Organizations in Moldova to examine the deliverables and review the conclusion of civil society. An overview of the 2020 deliverables evaluation will be presented at the Brussels General Assembly.





# The main recommendations for the general EaP framework are:

- EaP deliverables should be different for countries that have an Association Agreement with the EU.
- EaP activities must be more ambitious than the provisions of the Association Agreement with the EU
- EaP deliverables should help implement the legislation modified according to the Association Agreement.
- The civil society should be present at all EaP framework meetings to present the opinion of the society and not only that of the Government.

# **MOLDOVAN STYLE**

After several years of poor collaboration between the Government and the civil society and the influence of political parties that divided the Moldovan society on ethnic principles, the time for a new reality has come in line with the European values. The National Platform offered such an example by targeting an environmental issue which was usually overlooked by the authorities. In collaboration with the Ministry of Agriculture, Regional Development and Environment, the Agency for Interethnic Relations and with the participation of civil servants and representatives of all major national minorities in Moldova, the NP helped restore the protective strip of one of the main rivers in Moldova – Raut, by planting 4000 trees on its banks. Thus, the civil society and central authorities came together to unite people from different regions and of different backgrounds to fight a critical environmental problem that can leave Moldova without water in just 15 years.
