

During the plenary session, the Moldovan National Platform discussed the following subjects:

- The procedure for submitting new councilors for the code of ethics was discussed and two people were nominated.
- The results of the questionnaire to identify the needs of NP members were presented and other potential training topics were discussed.
- Proposed amendments to the NP rules of procedure were presented and other changes proposed by members.
- The launch of the statement on the arrest of the Attorney General was discussed.
- The possibility of organizing WG activities together with the EU delegation was discussed.
- It was agreed to organize a sanitation action with the NP members.
