President of the Republic of Moldova, Maia Sandu attended the Sixth Eastern Partnership Summit in Brussels on 14 and 15 December. The President Maia Sandu, gave a speech during the event, were she spoke about the elections, the reform of the judiciary, the support provided by the European Union, but also about the recovery of Moldova and the integration into the EU.

During her visit, President Sandu met with Heads of State and Government of the EEA and EU countries, as well as with senior European Union officials.

The delegation of Moldova included Cristina Gherasimov, Secretary General of the Office of the President, Nicu Popescu, Deputy Prime Minister, Minister of Foreign Affairs and European Integration, and Ambassador Daniela Morari, Head of the Moldovan Mission to the European Union.

The leaders of Ukraine, Georgia, and Moldova lobbied the European Union at the Eastern Partnership summit to allow them to start negotiations to join the EU, Reuters reports.


